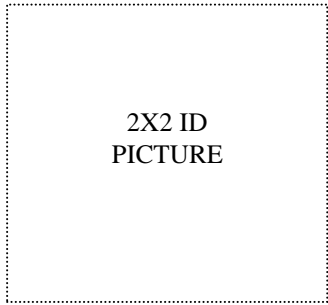

The undersigned hereby applies for membership in Biliran Electric Coop., Inc. (hereunder called the "Cooperative") and in consideration of the acceptance of this application agrees with the Cooperative as follows:

1. The undersigned will pay on demand to the Cooperative a membership fee of **FIVE PESOS (P 5.00)**.
2. When energy becomes available, the applicant will purchase from the Cooperative all electric energy used in the premises described above and will pay therefore, at the rates to be determined from time to time in accordance with the policies of the Cooperative, provided therefore, that the Cooperative may limit the amount of electric energy to be furnished for industrial users.
3. The undersigned will grant to the Cooperative at its request the necessary rights and easements to construct, operate, replace and perpetually maintain on the property owned for leased by the undersigned, and in or upon all roads, streets or highways abutting said property, its line or lines for the transmission or distribution of electric energy. All service supplying the undersigned with electric energy and all switches, meters and other appliances and equipments constructed or installed by the Cooperative on said property, except so much therefore, if any shall be paid by the Cooperative and the Cooperative shall have the rights of access to said property to repair service and upon the discontinuances of service for any reason to remove the same.
4. The undersigned shall have all the rights and privileges granted to members under Charter and bylaws of the Cooperative or any bylaws and all rules and regulations which may from time to time be adopted by the Board of Directors of the Cooperative.
5. The Applicants by paying a membership fee and becoming a member, assumes no personal liability or responsibility debts or liabilities of the Cooperative and it is expressly understood that under law his private property cannot be attached for any such debts or liabilities.
6. The applicants must purchase power from the Cooperative not later than six months from the date of his application for membership is accepted.
7. The consumer shall be held responsible and liable for tampering, interfering with or breaking of seals of meter or other equipment of the Cooperative installed on the Consumer premises and/or for any of the unlawful sets defined and enumerated under Section 2 and 3 of Republic Act 7832.
8. That the consumer shall be held responsible and liable for any of the existence and presence of the circumstances defined and enumerated under Section 4 of Republic Act No. 7832.
9. That the parties hereto have agreed that this contract shall be deemed subject to the provision of the Republic Act 7832 otherwise known as the "Anti-Pilferage Act of Electricity and Electric Transmission Lines/Materials Act of 1994".
10. Violation or non-compliance of any of the above provisions constitutes a ground for the termination or cancellation of his membership.

The acceptance of this application by the Cooperative shall constitute agreement between the Cooperative and the undersigned upon the terms herein above set forth, and contract for electric service shall continue in force from the date service is made available by the Cooperative to the applicant and therefore until cancelled by at least THIRTY DAYS (30) written notice.
