

The years 2021 and 2022 are very challenging years for the ECs and MCOs in general and for BILECO in particular. 2021 was the changing of guards at the NEA, the supervising agency of the ECs, while 2022 is election year, where new leadership at Malacañan has just assumed at 12 noon of June 30, 2022.

With the new developments in the country, as an EC, together with the 120 others, BILECO must move forward. First, it has to work on its mandate of total electrification of its coverage area. Second, it has to give attention to enhance its capacities in the area of technical, financial and institutional, and even legal. Third, it has to generate massive support of the MCOs by seriously implementing MCOPE or the Member-Consumer-Owner Program for Empowerment. Fourth, it needs to carry beyond electrification agenda, such as rural enterprise development, if its mission is not just to electrify, but realize social and economic development in the countryside, most especially its MCOs. Seventh, the EC needs to adapt the new environment, the paradigm shift in terms of governance, especially in the social, economic, political, environment aspects, to be able to address the signs of the times.

As Warriors of Light and Advocates of Sustainable Rural Development and Genuine Nation Building, through the NCECCO or the National Center of Electric Cooperative Consumers, Inc., we need to further the Empowerment of the MCOs as a necessary factor towards the following objectives: 1. Preserve the gains of Rural Electrification Program, which became successful because of the ECs; 2. **New plantilla & probationary appointment**

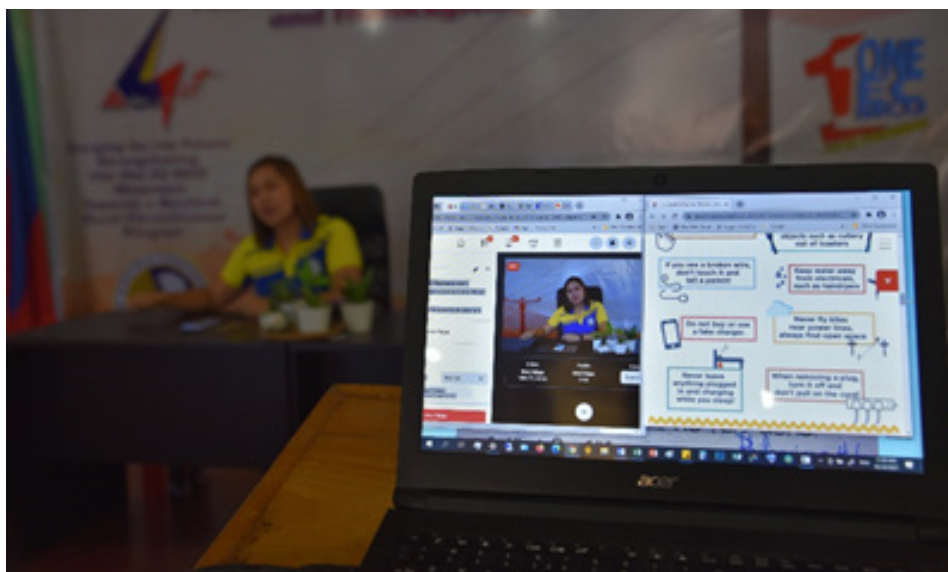

## Creation of CCSMO

Following NEA Memo No. 2018-022, the BOD, found it necessary to create the Cooperative Communications and Social Marketing Office (CCSMO) to intensify the coop's implementation of its Information Education Campaigns (IEC) and initiatives. The team composed of four personnel bears the job of improving the coop's image through massive information dissemination of coop programs and activities to its MCOs through multi-media channels.

## Seminar-Workshops

As part of human resource development program of the cooperative that aims to enhance the skills and competency of its employees, BILECO has successfully completed the 2-day seminar on Road Safety and Vehicle Management held on April 7-8, 2021, at Fragoch Conference Hall, Naval, Biliran and Ecalla Beach Resort, Talahid, Almeria. The participants were given a





chance to raise their questions and concerns to the speakers during the open forum. Also, a pledge of commitment was presented by each group as facilitated by Mr. Michael M. Gabing, HRA Supervisor. The management thru the leadership of GM Gerardo N. Oledan is set to conduct more competency enhancement seminar workshops.

**NEAM**

BILECO, together with 120 electric cooperatives, participated in NEA’s 12th National Electrification Awareness Month (NEAM) wherein line clearing and tree planting activities were conducted simultaneously nationwide on August 11, 2021. The tree planting was done in Brgy. Villaconsuelo, Naval, one of the affected areas during ST Yolanda in 2013, whereas the line clearing was conducted from Brgy. San Juan, Brgy. Calumpang to Brgy. Villaconsuelo, Naval. The said activity was spearheaded by GM Gerardo Oledan and was participated by the board of directors and the coop employees.



**Handog Pamasko**

Southern Leyte province was greatly affected by Typhoon Odette last December 16, 2021, particularly the franchise areas of LEYECO IV and SOLECO. BILECO started a donation drive thru its Facebook page to be able to help these electric cooperatives. The coop accepted donations from its MCOs including grocery packs, used clothing, gallons of purified water, rice and other basic necessities. These donated goods and items were delivered by BILECO to Southern Leyte for the victims of Typhoon Odette.

**NO DISCONNECTION POLICY**

The Department of Energy (DOE) has directed BILECO and all other Distribution Utilities to implement a NO DISCONNECTION POLICY due to non-payment of bills falling due by March 2021 for all electricity consumers whose consumption level is within the lifeline rate set by the Energy Regulatory Commission (ERC). The said policy applied to all unpaid regular bills and installment payments relative to various advisories of the DOE and the ERC. For BILECO, this policy covered consumers with consumption of not more than 34 kwh.





## First virtual AGMA and SECA

BILECO successfully held its 33rd Annual General Membership Assembly (AGMA) and first-ever State of the Electric Cooperative Address (SECA) virtually on November 19, 2021, with a total registered attendees of 5,718 from all over the franchise area. During the e-affle draw, one hundred ninety-six (196) MCOs from the different districts were chosen as the lucky winners who received consolation, minor, major, and grand prizes. It was also the first AGMA conducted after the COVID-19 pandemic.

## Pre-Membership And Orientation Seminar

A total of 220 NHA beneficiaries attended the Pre-Membership Orientation Seminar (PMOS) conducted by BILECO at Villa Enage, Biliran on January 20, 2021. The same was done at the Naval Municipal Gymnasium on 17 September 2021, to about 296 beneficiaries of Cool Mont Crest, an NHA housing site located in Brgy. Villa Caneja, Naval.

BILECO policy, brief history about the coop, process in applying for new connection, and the responsibilities and rights of a member were among the topics discussed in the seminar by the Member Development Officer (MDO) Evelyn D. Olimba and Customer Service Representative (CSR) Roland Cabillan. One of the requirements in applying for power service connection within the franchise area is to undergo the PMOS or Pre-Membership Orientation Seminar of the coop.



## Electricians Accreditation

An additional 32 electricians were augmented to BILECO's list of accredited electricians after an accreditation was conducted by the coop on 5 February 2021. They were oriented first on their responsibility being the partner of BILECO in its electrification programs with a goal to better serve its MCOs especially those individuals or businesses planning to apply for new and additional connections. The technical engineers of the coop, discussed with them the functions of transformer, kilowatt-hour meter and service drop wire, including the types of poles and their



measurement. Also, electrical safety and how to properly install house wirings were taught to them. Participants also underwent a written exam followed by a practical examination to assess what they have learned from the accreditation.

## ELECTRIFICATION PROGRAM



On 21 January 2021, free house wiring materials were turned over by BILECO to 40 indigent MCOs from Kawayan District. It includes a meter board and safety switch with socket for each household. The distribution was facilitated by Kawayan Board of Director Mr. Wilberto Caridad. The Board of Directors of BILECO created this program to help MCOs with homes but financially struggling to have their own electric connection. There were 40 beneficiaries in every district of Biliran that had benefited from this initiative of BILECO.

### Task Force Kapatid

The bond and brotherhood between electric cooperatives thru Task Force Kapatid shine even brighter in times of calamity. Region 8 ECs once again demonstrated this act with the rapid deployment of TFK 157 both in Leyeco IV and SOLECO, two ECs ravaged by typhoon Odette. BILECO TFK is in Hilongos and Maasin, Southern Leyte since December 19 to assist both coops in the rehabilitation of lines damaged by typhoon Odette.



### NHA Energization

Two National Housing Authority (NHA) projects in Biliran were energized by BILECO in the first quarter of 2021, the San Antonio Village located in Brgy. Villa Enage, Biliran followed by the



San Lorenzo Heights located in Brgy. Guindapunan, Culaba. Local officials of the two municipalities and all Board of Directors of BILECO were present during the energization and switch-on ceremonies held in the mentioned places on February 23 and 26, respectively. NHA energization is part of BILECO's electrification programs through the leadership of General Manager, Engr. Gerardo Oledan, in line with the National Electrification Administration's (NEA) thrust to attain 100 percent electrification by 2022.

### Pailaw sa Bahay Tungo sa Magandang Buhay

BILECO bares new electrification initiative for indigent consumers called the 'Pailaw sa Bahay Tungo sa Magandang Buhay' program. One major objective of this program is to encourage and empower indigent MCOs to apply for power service connection and to help eliminate the existing illegal

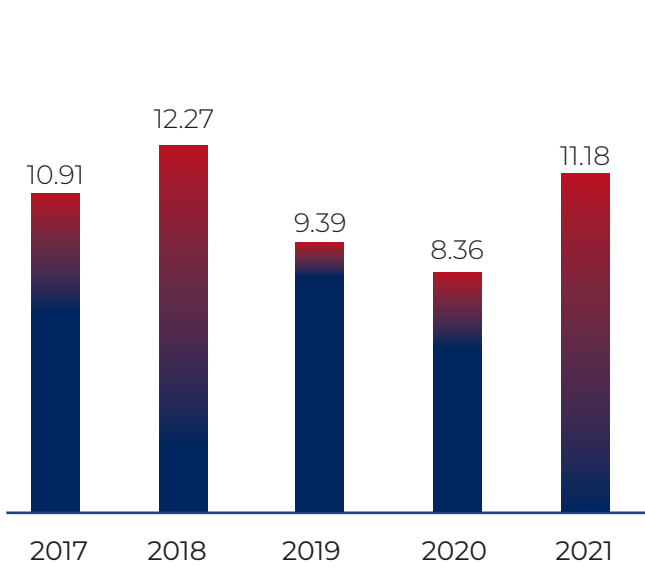


connections within the franchise. BILECO initially shoulders the expenses for housewiring installation and other coop fees which shall be paid later on by the beneficiary on installment basis which shall be 6 or 12 months depending on the capacity of the beneficiary to pay. Applicants shall pay only 5 pesos membership fee upon submission of the application requirements. Pailaw program becomes more beneficial and economical to prospective applicants after the Board waived some of the coop fees.

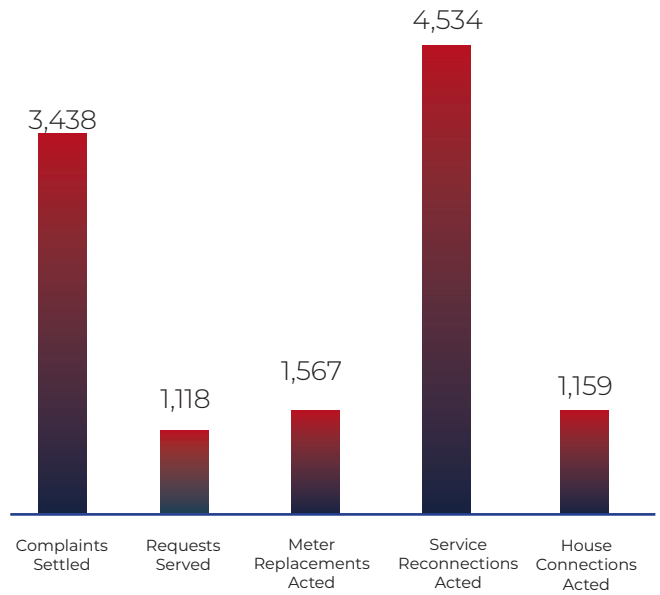


## FIVE-YEAR AVERAGE POWER RATE FOR RESIDENTIAL

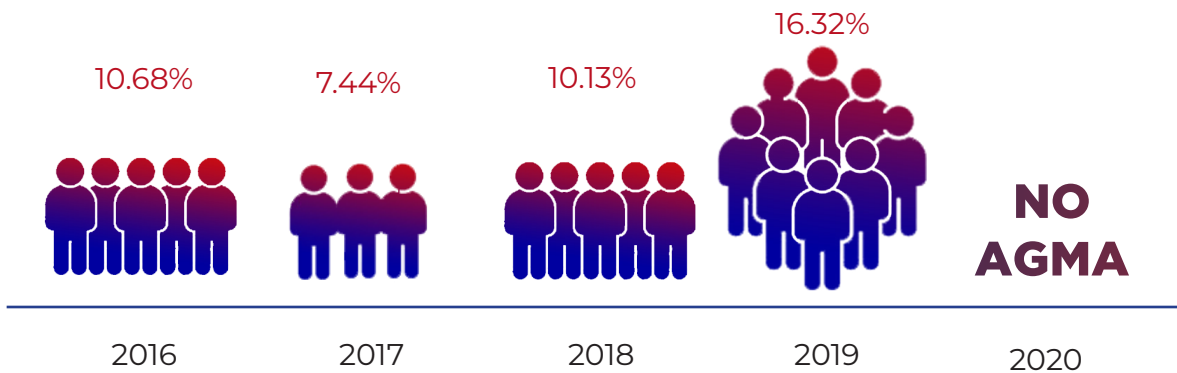
(in Pesos per KWH)

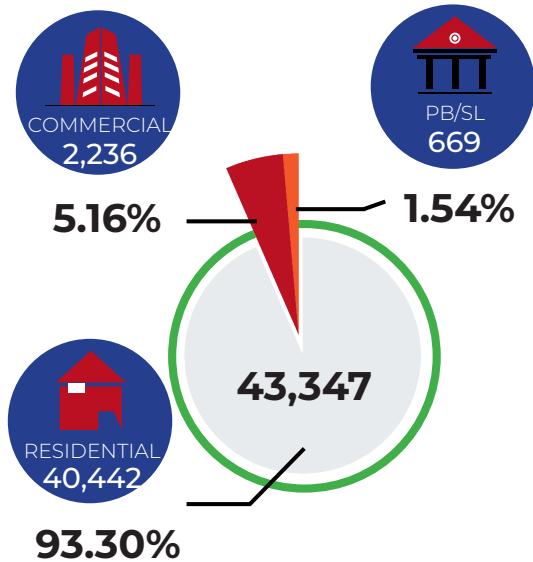


## FIVE-YEAR AGMA ATTENDANCE

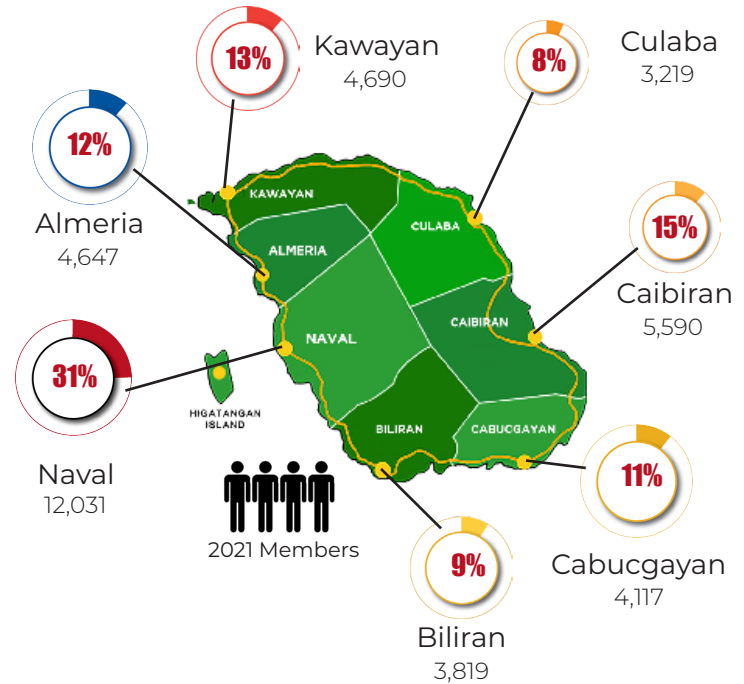

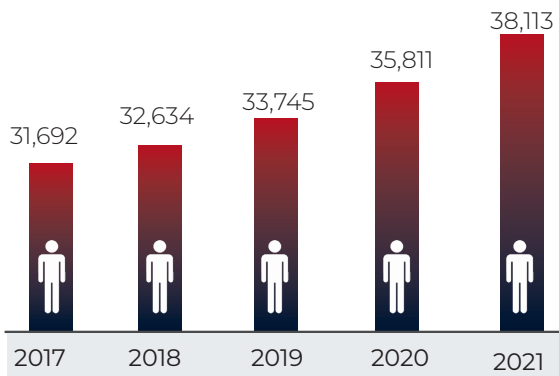

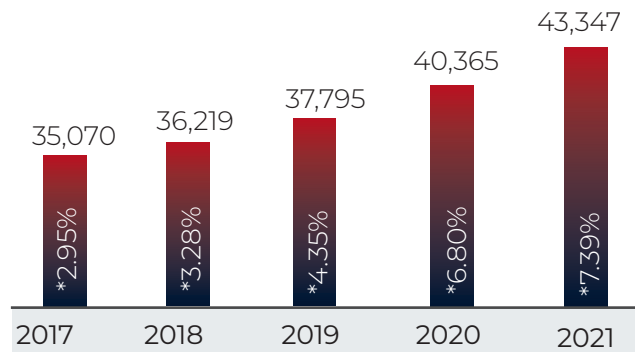

## FIVE-YEAR MEMBERSHIP GROWTH

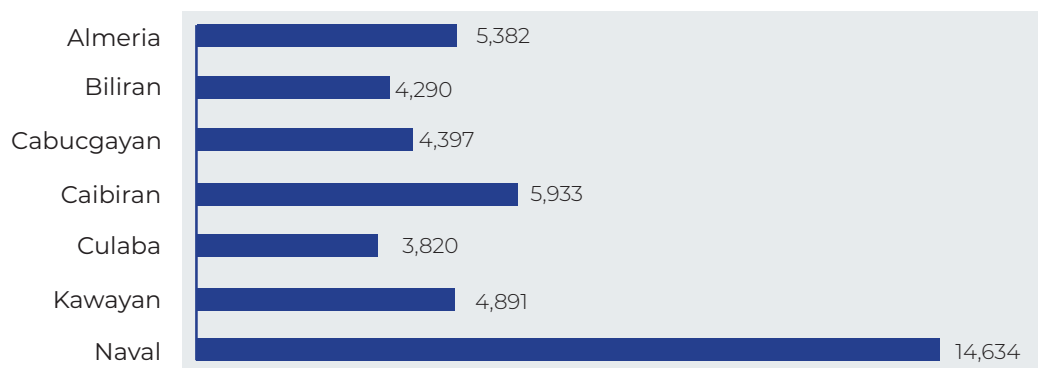


## FIVE-YEAR CONNECTION GROWTH

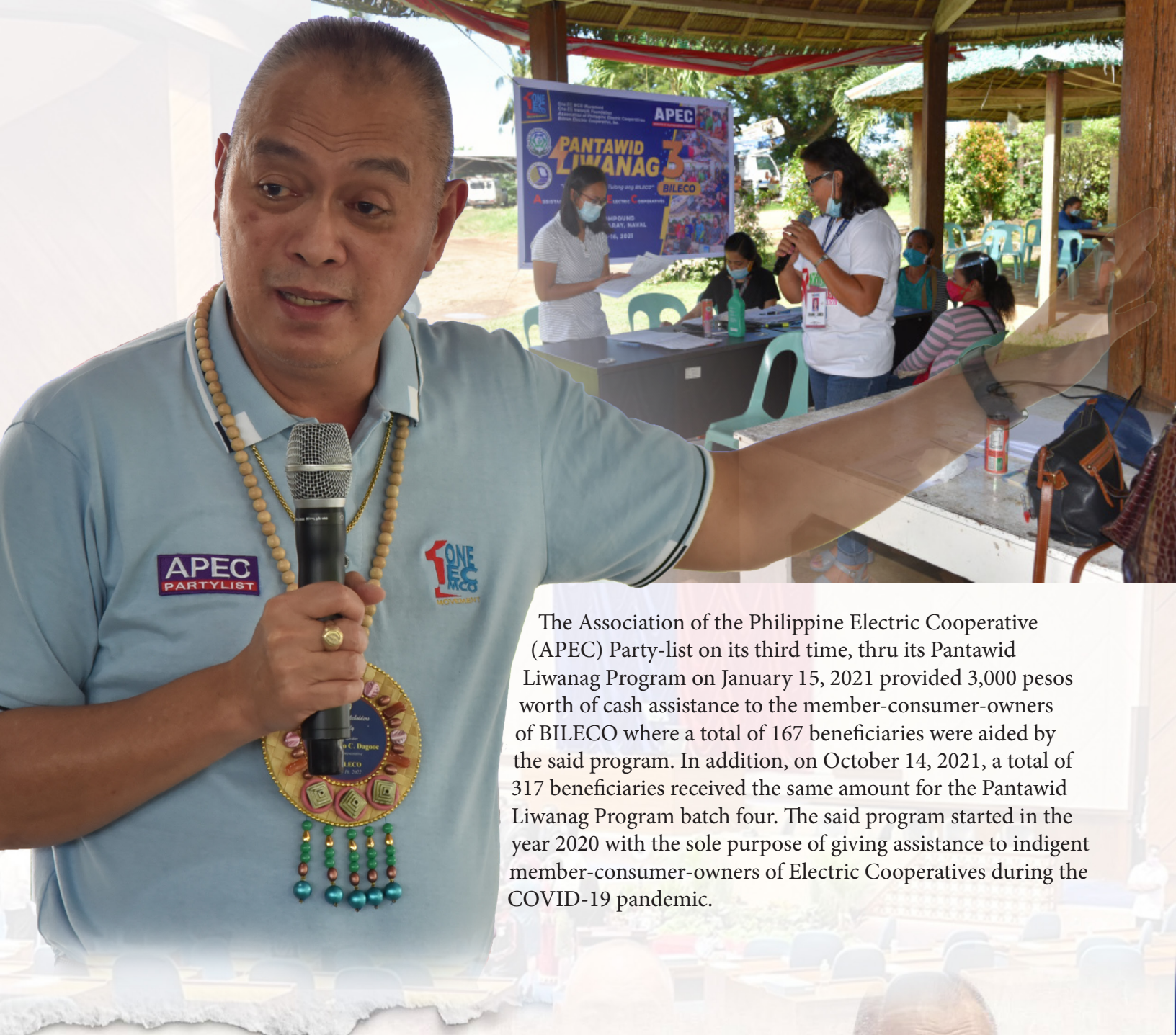

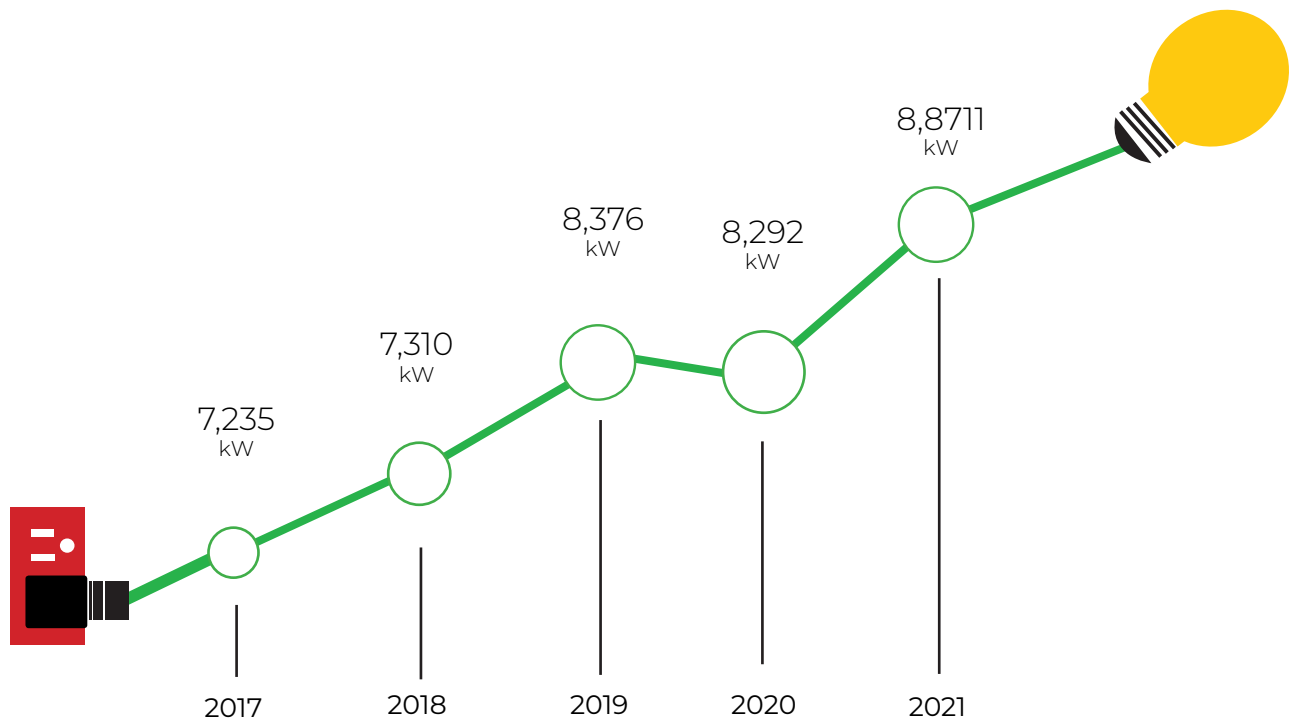

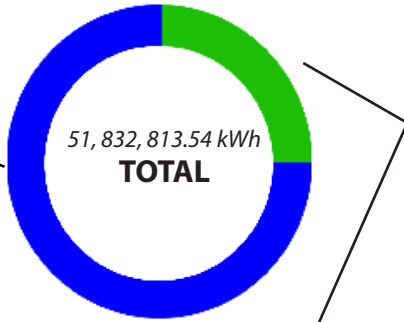

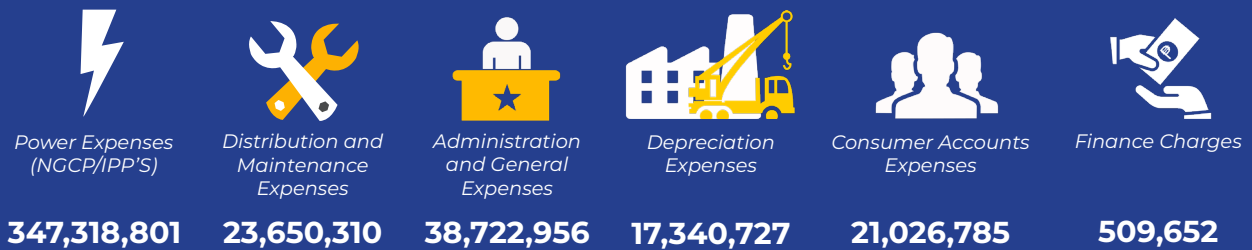

- BGI will upgrade BILECO's existing 13.2kV Distribution Lines from Lomboy, Naval to Pulang Yuta, Cabibihan, Caibiran (Route 1) and from Pulang Yuta to Cabibihan-Caibiran Intersection (Route 2);
- The memorandum of agreement (MOA) was duly signed and notarized last January 22, 2021;

**BILECO Approved DAS and DIS (BGPP)**

- The Distribution Asset Study (DAS) and Distribution Impact Study (DIS) which proved to be generally feasible

with the Distribution System Open Access Rules (DSOAR), PDC & PGC and favorable to the cooperative particularly on the improvements to the voltage profile and reduction of the daily technical losses;

- By virtue of Board Resolution No. 132 Series of 2021, the DAS and DIS was approved last August 10, 2021;

**Ongoing Applications and Compliances**

- Metering Service Agreement with the National Grid Corporation of the Philippines ("NGCP) for the Project to be compliant with the Philippine Distribution Code (PDC), Philippine Grid Code (PGC) and other applicable laws;
- Transmission Service Agreement with the National Grid Corporation of the Philippines ("NGCP);
- CAPEX Application with the Energy Regulatory Commission (ERC);
- ROW and Transmission Line ROW, local government permits and such other regulatory requirements in relation to the Project;

As stated in NEA Memorandum No. 2020-058, the ECs may conduct the above-mentioned activity for the said deferred DE and hold the regular DE originally scheduled in Year 2021, AGMA and other similar activities, provided that it shall ensure compliance to safety and health protocols issued by the Department of Health (DOH) and other authorities including securing of the required permits from local government units (LGUs) relative to the holding of the said activities;

In addition, NEA Memo 2020-058 states that ECs which will conduct virtual AGMA and other activities shall take into consideration the following:

1. Notice to all member-consumer-owners (MCOs) were given with proof thereof following the procedure in the EC By-Laws; and,
2. Attendance of participating MCOs to the virtual AGMA including voting of MCOs are duly recorded for future reference such as, for candidates in future district elections and other EC activities requiring submission of Certificate of Attendance to AGMA;

As per Section 3 of the Local Executive Order No. 32 Series of 2021 known as An Order Implementing Revised Travel Protocols and Quarantine Regulations in the Province of Biliran, the venue capacity for gathering has been increased from 30% to 50% in accordance to the Omnibus Guidelines for the Implementation of Community Quarantine in the Philippines, under the Modified General Community Quarantine Classification;

To accommodate all of the member-consumer-owners of the Biliran Electric Cooperative, the Board and Management of BILECO proposed for the conduct of the virtual annual general membership assembly and the online registration thereto.

### Report on the Audit of the Financial Statements

#### Opinion

We have audited the financial statements of BILIRAN ELECTRIC COOPERATIVE, INC. (BILECO) which comprise the statements of financial position as of December 31, 2021 and 2020, and the related statement of comprehensive income, statement of changes in equity and statement of cash flows for the years, then ended, with notes to financial statements including a summary of significant accounting policies.

In our opinion, the accompanying financial statements present fairly, in all material respects, the financial position of BILIRAN ELECTRIC COOPERATIVE, INC. as of December 31, 2021, and of its financial performance and its cash flows for the years then ended in accordance with Philippine Financial Reporting Standards (PFRS).

#### Basis for Opinion

We conducted our audit in accordance with Philippine Standards on Auditing (PSAs). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. #### Responsibilities of Management and Those with Governance for the Financial Statements

Management is responsible for the preparation and the fair presentation of the financial statements in accordance with Philippine Financial Reporting Standards, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Cooperative's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Cooperative or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Cooperative's financial reporting process.



## Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. 
